The Air Force Nuclear Weapons Center, Intercontinental Ballistic Missile Systems Directorate, Ground Based Strategic Deterrent Division (AFNWC/NIC) is releasing a request for proposals (RFP) for the Ground Based Strategic Deterrent (GBSD) Technology Maturation and Risk Reduction (TMRR) contract. The official solicitation number is FA8219-16-R-GBSD. Proposals submitted by interested offerors in response to this solicitation are due not later than 12 October 2016, 12:00 PM MST.

The government intends to award up to two Cost-Plus-Fixed-Fee contracts for TMRR. This effort is for RDT&E services with a period of performance of approximately 36 months. This effort is a full and open competition. The contract award(s) is expected in summer 2017.
